

PROCESSING OF PERSONAL DATA

I hereby state, as a sworn statement, that I am in full exercise of the powers vested in me and that I grant my prior, express and informed consent to Fundación Rewilding Argentina ("Rewilding") to collect, use, store, disclose, transfer internationally and otherwise process my personal data, including identifying data (such as name, surname, ID number, date of birth and place of residence and origin), contact information (such as e-mail address), information about my means of transportation (such as the type of transportation by which I access the park and, when applicable, its plate number), about my stay in the area and contracted excursions, about how I became aware of Rewilding and about my communication preferences (such as my agreement to receive Rewilding's newsletter) and to create a database with such data, for the purposes described in this authorization. In this regard, I understand and consent that:

- i) Fundación Rewilding Argentina, with domicile at Belgrano 1077, San Isidro, Province of Buenos Aires, Argentina is the data controller of my personal data.
- ii) The personal data will be used, based on your consent, to identify and keep control over those who carry out activities inside the Ibera National Park, Portal Carambola (the "Park") as well as to send general communications about your visit to the Park and marketing communications (including, but not limited to Rewilding's newsletter, when you have expressly required it). Likewise, the personal data may be processed with defense in trail purposes or for potential claims.
- iii) The provision of the personal data is absolutely voluntary, but in case of not providing the personal data or of providing false or inaccurate data I will not be able to stay in the Park and/or to participate in the proposed activities and/or to access to the services offered by Rewilding.
- iv) The personal data described in point iii., may be shared with a) other partner entities of Fundación Rewilding Argentina, including, but not limited to The Conservation Land Trust Argentina S.A.; b) third party service providers, including data processing vendors; c) public authorities when a formal petition in that regard was received by Rewilding or its affiliates or when a law specifically orders such disclosure.

v) The personal data will be stored for as long as necessary to comply with the purposes for which it was collected and for longer period when applicable law requires so, even after my relationship with Fundación Rewilding Argentina is over.

vi) I will be able to access to the personal data and to request the rectification, updating and/or deletion of the personal data by sending an e-mail to info@rewildingargentina.org. I will also be able to request the blockage of my personal data from any marketing databases of Rewilding and to revoke my consent to the processing of my personal data at any time. However, I understand that such revocation will not have retroactive effects in any case.

vii) The Argentine Agency of Access to Public Information, supervisory body of Personal Data Protection Law No. 25,326, is entitled to receive claims and complaints in connection to the breach of Personal Data protection rules.
